Finally, it is sent for the President's consideration. The President has ten days to sign or veto the enrolled bill. If the President signs the bill, it becomes law. If the President vetoes it, the bill can still become a law if two-thirds of the Senate and two-thirds of the House then vote in favor of the bill. And that is how laws are made!
