Risk assessment is the collection and analysis of information to determine the degree to which key factors are present in a family situation that increase the likelihood of future maltreatment to a child or adolescent. Many child welfare agencies use safety or risk assessment instruments to help workers assess families.

In some circumstances it will be important to understand the level of harm suffered by the child or young person and whether this meets the threshold for referral to Children's Services. This Risk Assessment builds up an understanding of the risk of significant harm.
